

Trifecta Crop Control is a revolutionary product representing a paradigm shift in managing problem with both pests and fungal infestation in agriculture.

Traditional approaches required highly toxic doses of chemicals where the negative repercussions due to exposure were often worse than the cure. Trifecta Crop Control is made of nano-sized droplets of essential oils held in a colloidal suspension. The oils in Crop Control are in such a small suspension that when diluted in water light is barely refracted. These oil droplets are so small that they manage to become systemic in the plant. Testing has shown that as a managed maintenance program regular use with Trifecta will prevent infestations. Using a hermetically sealed room plants were grown from seed and treated bi-weekly with Trifecta for three weeks and then exposed to rooms with Broad Mite and Russet Mite infestations.

Untreated controls were exposed simultaneously. The treated plants showed no symptoms of infestations after 72 hours of exposure time. Live bugs were found on the controls after 10 minutes exposure. The essential oils in Crop Control were chosen for specific terpene content which causes lysis in fungal cells where they swell and burst and dry out completely, and can then be rinsed away. Crop Control has been proven effective against Botrytis, Powdery Mildew, Downy Mildew, Black Sigatoka and others.

## DIRECTIONS FOR USE → Shake well before diluting.

**FOR PREVENTATIVE MAINTENANCE:** Dilute 1/2 oz. of Crop Control for every gallon of water. Apply Crop Control using an atomizer, misting system or a spraying apparatus. Thoroughly wet the plants until foliage is dripping including the underside of the leaves. Minor wilting of feeder leaves may occur until the plant is acclimated to Crop Control. Preventative applications should be applied 1 time per week and on the same day each week.

**FOR INFESTATIONS:** Dilute 2 oz. of Crop Control for every gallon of water. Apply Crop Control using an atomizer, misting system or a spraying apparatus. Thoroughly wet the plants until foliage is dripping including the underside of the leaves. Minor wilting of feeder leaves may occur until the plant is acclimated to Crop Control. Crop Control should be applied every other day up to 3 times per week until infestation is controlled. Apply Crop Control at the end of a light cycle or just before dusk to prevent foliar damage.
